Topic: Sports for Development

<u>Taking into account</u> that some countries are trying to improve overall economic and infrastructural development,

<u>Understanding</u> that sports can provide a platform for growth in infrastructure, economic stability, cooperation, communication, and education,

Referencing the Millennium Development goals: Goal 3, "Promoting Gender Equality and Empowering Women," Goals 5 and 6, "Improving Maternal Health and combating HIV/AIDS, Malaria, and other diseases," and Goal 8, "Developing a Global Partnership for Development,"

<u>Taking into account</u> the need for stronger financial assistance for sports development in smaller underprivileged communities,

<u>Addressing</u> the need for easy access of sports education to woman and children, <u>Aware of</u> the lack of motivation among the disabled,

<u>Taking into consideration</u> the need to motivate and support sports education for the disabled,

Recognizing the need to promote awareness through social media for gender equality and the disabled in sports,

- 1. Opens a UN run sports league:
 - a. Proclaims this league all inclusive to children under 18 and above six, as well as to all races and ethnicities,
 - b. Encourages all sports to be for low income and at risk children,
 - c. Defines "children in need" as from families that cannot meet their basic human needs;
- 2. Calls for a worldwide tournament system including ages 11-15 from local to a global level that will lead to world cups and another nationwide tournament system including ages 8-10;
- 3. Draws the attention to the lack of knowledge about sports in rural areas, where the sponsors call for a worldwide organization that will use buildings funded by the World Bank that will hold sports programs;
- 4. Requests funding from developed countries like the United States and the United Kingdom to support sports program to help start and fund leagues in less developed areas for both children and women;
- 5. Calls for a worldwide Paralympics programs for 12 year old children and up to promote sports throughout all ages, closely resembling the modern day Olympics;
- 6. Endorses gender equality by creating sport programs and or league for women in all UN member states;
- 7. Notes the effect of sports on children, where the sponsors call for professional players to teach children how to play sports 5 times a year, for a day;
- 8. Draws the attention to the lack of funding for sports in rural areas, where the sponsors request for funding from the World Bank, and donations for professional leagues to provide equipment for leagues in less developed countries;
- 9. Notes the cost of the building needed for worldwide events, to build and modify these building so they can be uses in the future for other sports, and functions, like concerts;

- 10. Requests governments to provide fields in the out skirts of poor cities for the purpose of constructing sporting arenas in which to develop this resolution;
- 11. Emphasizes the need for infrastructure, the signatories call forth the world bank to provide funds for the fulfilment of this resolution;
- 12. Notes the cost for the buildings and decides that the sponsors call upon the member states of the UN to donate 0.5% of their GDP, plus and additional 10% of the funds raised by the member states will be requested from the World bank;
- 13. Uses some of the prospective funds from the Kingdom of Great Britain and Northern Ireland, the United States of America, and the World Bank to provide children in need with financial aid;
- 14. Notes the work of Qatar with portable soccer stadiums, the sponsors call upon the member states and the World Bank to provide approximately \$9 billion to build other stadiums that can be transported to countries that will host worldwide events.
