<u>Alarmed</u> by the fact over 740 million people do not have access to clean water which directly affects the health an unborn child and also by the fact that women are forced to carry the unsanitary water which affects their quality of life,

Emphasizing the importance of children's health,

Fully aware children four to five should learn about proper sanitation,

<u>Recognizing</u> the causes of child mortality: malnutrition, preventable diseases, lack of sanitation, and pre-mature pregnancy and birth,

Believing that we can achieve Millennium Development Goal 4, Reducing Child Mortality,

- 1. Approves of sending doctors and medications to underdeveloped countries by funding related organizations
- 2. Supports creating new NGO's that will help eradicate child mortality and provide beneficial education for mothers
- 3. Further recommends creating mobile NGO's that will provide vaccinations for children living I underdeveloped countries;
- 4. Further invited the providing of "Life Savor Bottles", water filters that can filter bacteria, viruses, and other pathological diseases;
- 5. Strongly condemns the usage of the "Maternity Box" which is an effective box that contains valuable objects for mothers with child care;
- 6. Recommends countries to open affordable and accessible clinics and hospitals
- 7. Further requests countries to ask medical/college students to volunteer in the less developed places which need medical help
- 8. Further recommends starting drives to donate resources to countries with high child mortality rates;
- 9. Calls upon countries to donate mosquito nets to families that are exposed to malaria carrying insects
