Topic: "Ensuring Access to Affordable Energy Services"

Alarmed by the lack of renewable and sustainable energy in many countries,

Noting with deep concern that the majority of less economically developed countries (LEDCs) do not have significant education or infrastructure to make use of their natural renewable energy resources,

Aware of the fact that low income communities cannot afford to the necessary equipment to install and maintain renewable energy,

Deeply disturbed by the fact that 20% of the earth's population does not have access to affordable, sustainable and renewable energy resources,

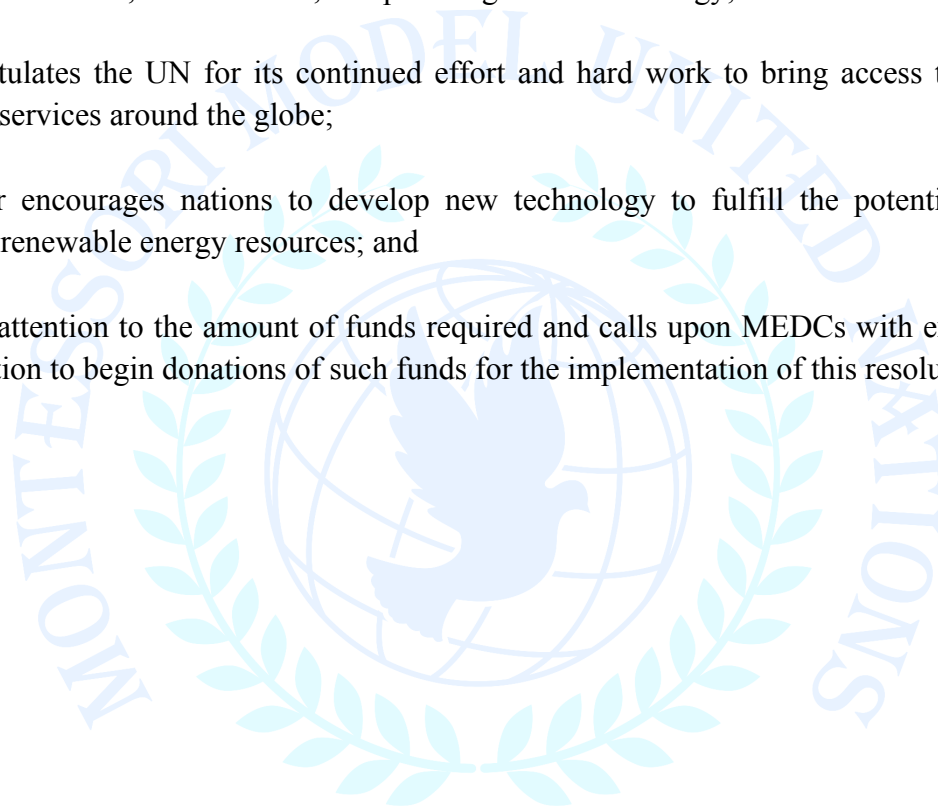
Expressing its appreciation for the effort and hard work the UN has put forward to ensure access to affordable energy services,

Noticing that the world is not taking advantages of the vast potential that countries hold in terms of natural renewable energy services,

Concerned by the lack of funds to provide low-income communities with affordable renewable energy,

1. Emphasizes the need for worldwide sustainable, renewable and reliable energy that is accessible to LEDCs as well as more economically developed countries (MEDCs);

2. Considers creating a fund and program to teach uneducated communities on how to make use of their natural and renewable energy services;
3. Recommends the creation of an incentives program that can realistically ask MEDCs to provide funds for LEDCs so that rural and low income communities can afford the infrastructure to install and maintain renewable energy services;
4. Encourage nations to switch to using renewable energy resources such as hydro, solar, tidal, wind, geothermal, clean nuclear, and plasma gasification energy;
5. Congratulates the UN for its continued effort and hard work to bring access to affordable energy services around the globe;
6. Further encourages nations to develop new technology to fulfill the potential posed by natural renewable energy resources; and
7. Draws attention to the amount of funds required and calls upon MEDCs with excess energy production to begin donations of such funds for the implementation of this resolution.
